CONDITIONS

Sunrise Birding, LLC walks, though not particularly strenuous, are intended for persons in reasonably good health and physical condition. Participants must be capable of walking over uneven terrain and be adequately prepared for the prevailing outdoor conditions. By registering for any Sunrise Birding, LLC program, you certify that you are in good health and physical condition and do not have any physical disability, medical condition, or other limitation that would create a hazardous situation for you or other participants.
